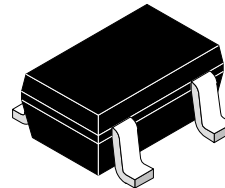
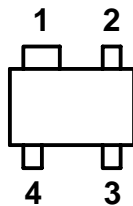


Applications

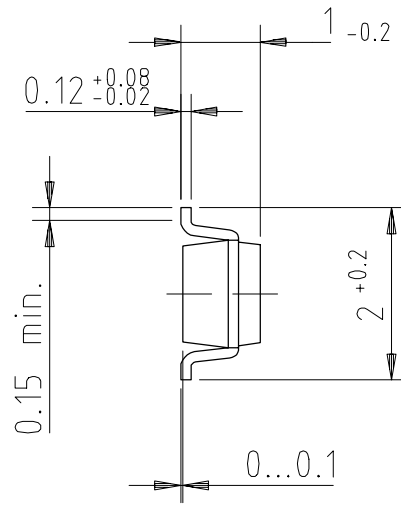
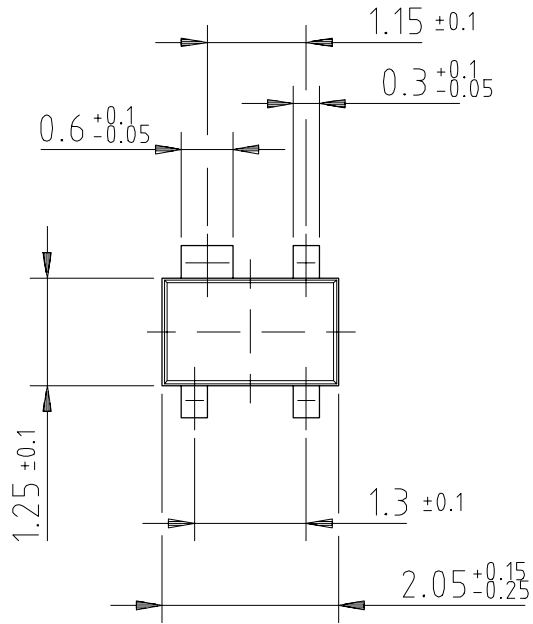

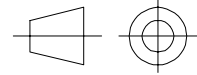
